This letter requests action by your Board to apply to participate in the World Health Organization/AARP Age-Friendly Cities and Communities Network. Action entails submission of an application, a letter of commitment and a resolution.

In 2017, your Board instructed the Health Care Services Agency and Social Services Agency to constitute a new body, the Council for Age-Friendly Communities, to be a collaboration of public and private entities committed to breaking down silos and working together to address the needs of the growing population of older adults in our County. The Council has met monthly since 2017 and begun work on a number of goals laid out in the County's Plan for Older Adults. One of the goals of that Plan included embarking on the World Health Organization and AARP Age-Friendly process.

318 communities within the United States have already joined the Age-Friendly network, including our County and the Cities of Berkeley, Emeryville, Fremont, and Oakland. Participating counties within California are Los Angeles, Marin, San Diego, San Francisco, Santa Clara and Sonoma. The global network currently includes 705 cities and communities in 39 countries.

The Age-Friendly rubric involves eight domains of livability that make a community livable for people of all ages. Creating an Age-Friendly County means identifying specific opportunities within each domain to advance the larger goals. It is up to each community to prioritize interventions, and there is no need to address all domains at once. The domains are:

Domain 1: Outdoor Spaces and Buildings

Domain 2: Transportation

Domain 3: Housing

Domain 4: Social Participation

Domain 5: Respect and Social Inclusion

Domain 6: Civic Participation and Employment

Domain 7: Communication and Information

Domain 8: Community and Health Services

Some communities, including City of Fremont, have added a ninth domain, Dementia-Specific Support, or made some revisions to these domains, such as renaming Domain 8 "Health and Wellness" or rearranging the elements within domains. The WHO/AARP process provides flexibility to adapt the approach to meet local needs, so that should we embark on this path, we will have the ability to make changes as needed.

Participation in the Age-Friendly process involves four steps:

- Application, Letter of Commitment and Resolution This is the current step, and membership will
 be complete upon the acceptance of the County's application and accompanying documents and
 designation of the County of Alameda as a member of the Age-Friendly Network.
- Information Gathering and Planning This involves conducting a community survey and creating
 an action plan. This is typically a two-year process, the first 18 months of which coincide with the
 development of our 2021-24 Countywide Plan for Older Adults, developed under the auspices of

our Area Agency on Aging (AAA) and the Advisory Commission on Aging. The Plan currently in force, for 2016-20, including the community survey that informed its findings and recommendations, was developed with the participation of a large planning committee, which formed the foundation for our Age-Friendly Council. Our AAA has already begun the process of coordinating closely with the Council, whose Age-Friendly Committee is tasked with overseeing the Age-Friendly process. The survey that the AAA disseminates this year for its planning process will also feed into the Age-Friendly planning process. By the same token, the Council will have an opportunity to provide input into development of questions for focus groups to be conducted later in the year. While the AAA has statutory requirements that define its planning process and the structure and content of its plan, it is our intention that the plan that emerges from that process will be consistent with and complementary to the Action Plan that emerges from the Age-Friendly process. The Action Plan will be presented to your Board for review and approval.

- 3. Implementing the Plan After the Action Plan is approved, we will then move into implementation. The details of the implementation will depend upon the elements of the plan.
- 4. Evaluating the Work Pursuing Age-Friendly is not a project that we will soon finish and then can be evaluated. Rather, Age-Friendly represents a commitment to a new way of doing business over the long term. The County has already committed to Results Based Accountability. A critical part of this work will be adding the lens of age-friendly to the work we are already doing, assessing our activities and progress according to how well they serve the needs of the County's older residents.



- 8. Community Support and Health Services access to homecare services, clinics, programs to promote active ageing (physical exercise and healthy habits); and
